

## Privacy Policy

Welcome to the Cynorix Inc. Website ([www.Cynorix.com](http://www.Cynorix.com)) (the "Website").

Please read this Privacy Policy carefully. These terms, as modified or amended from time to time, are a binding contract between Cynorix ("we" and/or "us", etc) and you ("you").

You may only use the website(s) operated by Cynorix if you first accept this Privacy Policy.

### WHAT THIS PRIVACY POLICY COVERS

This policy covers how Cynorix treats personal information that is collected or received through the services we provide. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and any information that is not otherwise publicly available.

This policy does not apply to the practices of companies that we do not own or control, or to people that we do not employ or manage. Companies such as our Internet access and website and email hosting company, Facebook, and others have their own privacy statements which can be viewed on their respective websites.

### INFORMATION COLLECTION AND USE

Cynorix collects personal information when you use the Website. For example, when you use the Website, we may ask you to provide us with personal information such as your name, email address, and a contact phone number.

The Cynorix website automatically receives and records information on our server logs from your browser, including your IP address, type of browser used, and the page you requested. The information from the server logs is used for general website administration and optimization and is NOT matched or otherwise correlated to individual users.

Cynorix uses the information that is collected for the following general purposes: to provide updates to you regarding products and services, to fulfill your requests for products and services, improve products and services, contact you, conduct research, and to optimize and improve the website.

### EMAILS

We will occasionally send e-mails to you. This is required for certain uses of the Website such as user registration. We may also send information to you regarding your account activity and purchases as well as updates about our products and promotional offers. You may elect to opt-out of receiving promotional emails at any time after registering by e-mailing [remove@Cynorix.com](mailto:remove@Cynorix.com) and including the email address you want to remove in the subject line. You need to send a separate email for each of your emails you want to be removed.

## CHILDREN

Cynorix does not design any part of its website to attract anyone under age 18. Cynorix will not knowingly contact children under age 18 without a parent's permission. Cynorix does not knowingly ask a child under age 18 for any personal information.

## INFORMATION SHARING AND DISCLOSURE

Examples of the Usage Information we may collect include:

- your IP address or unique Device Identifiers;
- your Device functionality (e.g., browser type, operating system, hardware, mobile network information, etc.);
- the URL that referred you to the Cynorix Services;
- the areas within the Cynorix Services that you visit and your activities there, including remembering you and your preferences, for example which videos you are viewing
- your Device location (including using GPS and longitude and latitude location information);
- your Device characteristics; and
- certain other Device data (e.g., the time of day when the Device is used to access our services).

Except as otherwise set forth in this Policy, we may use the information that we collect about you through the Website for improving our service quality, unless prohibited by applicable laws and regulations.

Cynorix does not rent, sell or share personal information about you with other people or companies except under the following circumstances:

- We provide shipping information to our shippers so that they may deliver products to you, when applicable.
- We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims.
- We share information with law enforcement agencies in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, suspected

copyright infringement, situations involving potential threats to the physical safety of any person, or as otherwise required by law.

Please note that this Policy does not limit Cynorix's use or sharing of aggregated, deidentified or other anonymized information that does not constitute Personal Information). We may use and/or share such information in any manner not otherwise prohibited by this Policy or by applicable law, without notice or compensation to you, for the purpose of improving the quality of our services.

Cynorix may disclose your information in the event we file for bankruptcy, or in connection with certain types of business transactions. For example, if Cynorix is or may be (or substantially all of its assets are or may be) acquired by another party pursuant to an acquisition, merger, sale, reorganization, liquidation, asset exchange, or similar business transfer, we may disclose and transfer your information to the parties involved in the transaction.

#### CONFIDENTIALITY AND SECURITY

We limit access to personal information about you to only those we believe reasonably need to come into contact with that information to provide our products or services to you. We have physical, electronic, and procedural safeguards to protect personal information about you.

#### COOKIES

We may use technologies such as cookies to collect information about the pages viewed by you, the links clicked by you and other actions taken by you on our website and services. Additionally, we collect certain standard information that your browser sends to every website visited by you, such as your IP address, browser type and language, access times and referring website addresses.

#### CHANGES TO THIS PRIVACY POLICY

This policy will be changed from time to time to adapt to the changing needs of the society and the law. We will notify you about significant changes in the way we treat personal information by amending this Privacy Policy on the website.

Note that this document is prepared to cover "Privacy Policy" generally applicable to all Cynorix products and website. For each product, as applicable, the general "**Privacy Policy**" described in this document will be accompanied by additional remarks, under the title of "Product Privacy Policy", that will be specific to that particular product.
